Resolution Reconfirming Our Commitment to the Principles of

- to teach, conduct and publish research, and speak and write both on campus and off, and that are crucial to ensuring our students receive the highest quality education possible; and,
- 6. Whereas ô We, the Columbia University Senate, believe that the protections of academic freedom allow and oblige all faculty to pursue their teaching, research and clinical endeavors and communicate to a wider public in ways that strengthen our society and affirm the social importance of higher education; and,
- 7. Whereas ô We, the Columbia University Senate, are committed to the rights and responsibilities of faculty as stewards of the institution, in the interest of its long-term well-being, and its capacity to be of benefit to its students, its immediate community, and the world at large;
- 8. Therefore, be it resolved that the Columbia University Senate is committed to the following principles of academic freedom and shared governance:
 - a. Academic activities at Columbia are subject to review set by normal institutional processes in accordance with best professional practice; and
